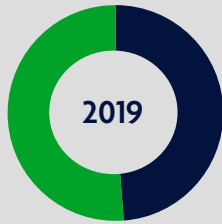

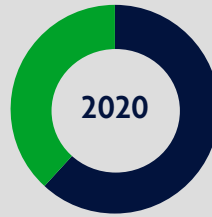

Domestic vs International Spending:

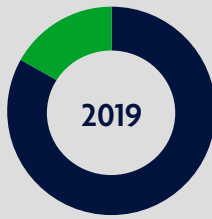


- Domestic Spending: **USD 8.5BN (49%)**
- International Spending: **USD 8.9BN (51%)**

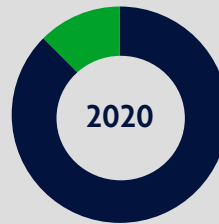


- Domestic Spending: **USD 3.9BN (62%)**
