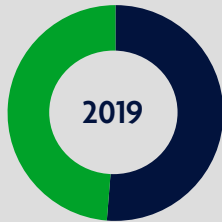

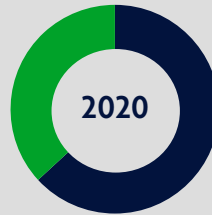

#### Domestic vs International Spending:

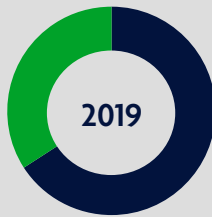


- Domestic Spending: **USD 3,088.9MN (51%)**
- International Spending: **USD 2,934.4MN (49%)**

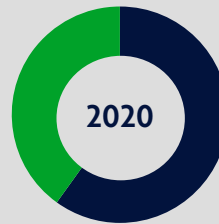


- Domestic Spending: **USD 1,658.4MN (63%)**
